

# General conditions of use of the site

## 1. Preamble :

The website [www.carsys.be](http://www.carsys.be) is provided by Michel Lecrombs SA (a limited liability company under Belgian law) whose registered office is located at 6, rue André Feher, B-6900 AYE, and whose registration number in the Legal Persons Register is 0462.340.404.

## 2. Presentation of the website [carsys.be](http://carsys.be) :

The [carsys.be](http://carsys.be) website is a platform for purchasing a wide range of new and used vehicles.

The [carsys.be](http://carsys.be) Website is available 24 hours a day, 7 days a week, unless interrupted for scheduled maintenance, and offers vehicles for sale with:

- A detailed description of the technical characteristics of each vehicle;
- Detailed photos of each vehicle;
- A detailed indoor/outdoor condition report;

The [carsys.be](http://carsys.be) Website is strictly reserved for a clientele composed exclusively of professionals in the automotive sector.

## 3. Acceptance of the General Terms and Conditions:

Please read these Terms and Conditions carefully before using or purchasing from the [carsys.be](http://carsys.be) Website. You are invited to print them and keep a copy.

The use of the [carsys.be](http://carsys.be) website implies the unreserved acceptance of these General Terms and Conditions of Use, as well as our Privacy Policy and General Terms and Conditions of Sale.

You are responsible for carefully reviewing these General Terms and Conditions governing the use of the [carsys.be](http://carsys.be) Website each time You wish to use it, insofar as certain changes may be made without notice.

## 4. Use :

## 6. My [carsys](http://carsys.be)" space:

### 6.1. Registration process :

To use all the features of the [carsys.be](http://carsys.be) Website, You must first register. Without an account, you will not be able to purchase a vehicle, receive alerts, participate in auctions, edit customized commercial offers and/or contact us for information on one or more vehicles.

Registration on the [carsys.be](http://carsys.be) Website is free of charge.

The application to register on the [carsys.be](http://carsys.be) website is made via an online form.

#### 6.1.1. Profile of a [carsys.be](http://carsys.be) account :

When you register, you must fill in all the fields designated on the form according to the different steps of the registration procedure.

Thus, You must indicate in particular:

- Your name and full address
- Your intra-community VAT number
- The name of your purchasing manager
- Confirm your quality as a professional in the automotive sector etc.

#### 6.1.2. Contact details of the carsys.be account holder

You must also enter your personal details and a strictly personal password.

Each registered user guarantees that the data they provide is accurate, complete and up to date.

#### 6.2. Use of the carsys.be account

To ensure the confidentiality and security of the carsys.be Website, You must ensure that the confidentiality of your login ID and password is respected. You must not communicate your username and/or password to anyone.

You are solely responsible for protecting the confidentiality and security of your username and password. In case of use by a third party of your username and password, You must notify Michel Lecrombs SA as soon as possible.

You are also fully responsible for all actions carried out on the carsys.be Website using your login and password. In the event of loss or theft of your login and/or password and/or inability to connect to your carsys.be account, you must inform Michel Lecrombs SA as soon as possible using the available function by completing the contact form provided for this purpose on the home page of the carsys.be Website. A new password will then be sent to you by email. You are encouraged to change your password regularly to ensure greater security.

You will then be invited to contact Michel Lecrombs SA who will accompany You to regularize the situation and will then be able to reactivate your access to your carsys.be account.

#### 6.4. Functionality of the carsys.be account

By creating a carsys.be account as a professional, you will be able to:

- Update your information.
- Register the vehicles that interest You.
- Edit personalized offers with your logo, price list and VAT rates on behalf of your customer.
- Buy vehicle(s) at fixed prices or through auctions
- Download on line all the photos of the vehicles purchased

### 7. Intellectual Property

The carsys.be Website constitutes an intellectual work protected by copyright and author's rights, as well as other international intellectual property laws.
